<u>22/02308TCA Freshford Cemetery, The Tyning, Freshford:</u> Willow-leafed pear reduce crown by 25%; Common Oak raise low canopy to 2m as per submitted tree survey.

<u>22/02491/TCA Fairlawn, High Street, Freshford, BA2 7WF:</u> Mature Walnut & Cotoneaster reduce crown by 10/15% and reduction of weight on branches overhanging the highway.
